If you wish to transition your paper protocol into eProtocol IACUC, you must keep your paper protocol active until your eProtocol is approved. # Inside the IACUC: Types of Protocol Review

Part 3 of 3

While Federal regulations allow for two types of review of animal use protocols: Full Committee Review (FCR) and Designated Member Review (DMR), recent guidance from the Office of Laboratory Animal Welfare (OLAW) granted authority for a small number of items to be administratively approved.

Administrative Review: Amendment applications to existing protocols that involve certain changes not considered significant (e.g., addition of a new funding source, changes in personnel (other than PI changes), use of a new vivarium housing location, etc.) can be reviewed administratively. Typically, the turnaround time for applications undergoing administrative review ranges from a few days to a week.

## Don't Forget to Cite IACUC Approval When Publishing

When publishing a paper from work that utilized vertebrate animals, remember to provide a reference that the work was approved by the IACUC. For example:

The University of Texas at Austin Institutional Animal Care and Use Committee (IACUC) has approved the use of vertebrate animals under UT IACUC Protocol #xxxxxxxxx).

### Common Deficiencies Identified During Semi-Annual Inspections

- Poor sanitation. Clean and sanitize animal housing, surgery and surfaces, and equipment areas regularly. Post cleaning and sanitation schedules, record dates performed.
- Inconsistent personal protective equipment (PPE) usage. Wear uniforms, scrubs, or laboratory coats as indicated.
- Unsecured gas tanks. Secure all gas tanks to prevent injury to people and animals.
- Inadequate facility maintenance.
  Repair damage to facilities, i.e.,
  flaking paint, holes, broken lights,
  leaking faucets, blocked sinks,
  promptly.

#### eProtocol Tip of the Month

Allow Pop-Up Windows when using eProtocol IACUC. Pop-up blocking software prevents the eProtocol application from opening certain windows. You'll need to make sure that your browser has all pop-up blocking software disabled while using eProtocol IACUC.
