The User's Guide covers everything from protocol creation to protocol approval (and everything in between, such as the eProtocol Review Process, finding and responding to review comments, etc.)

School's Out for the Summer: Update Protocol Personnel Lists!

Use the modification form or a quick email to IACUC@austin.utexas.edu to remove students that will no longer work on your protocol(s) and to add new members that will be joining your lab over the summer.

If you have an eProtocol, then you must initiate the personnel modification online, by beginning a protocol REVISION.

Remember, personnel changes should be done in real time (i.e., when people join or leave a lab) and not on an annual basis (i.e., at the time of the annual renewal).

Post-Approval Monitoring (PAM)

The purpose of the Post-Approval Monitoring Program (PAM) is to ensure that research and teaching activities involving the use of live or dead vertebrate animals are conducted in accordance with all applicable regulations and are consistent with the Principal Investigator's IACUC-approved Animal Utilization Proposal and amendments.

Any approved Animal Utilization Proposal may be subjected to post approval monitoring. Usually, protocols will be selected during initial review, during the review of new procedures, or at the time of the annual renewal. Pl's will be asked to coordinate post-approval monitoring with Animal Resources Center (ARC) staff.

The next IACUC Full-Committee Review (FCR) is **July 13, 2009**.
