eProtocol Tip of the Month

What is the best way to describe a terminal tissue harvest in the procedures section?

We frequently receive this question. If tissues need to be collected while the animal is still alive (e.g., under anesthesia) then the protocol needs to describe the anesthesia methods. If tissues will be collected after euthanasia, then the protocol needs to describe the harvest procedures.

To assist investigators in properly describing terminal tissue harvests, the eProtocol IACUC procedures list has been updated:

- Tissue Harvest (non-survival under anesthesia) should be selected for all procedures in which animals are anesthetized for tissue harvest.
- euthanasia) should be selected for all procedures in which animals are first euthanized for tissue harvest. Because post-mortem harvest procedures occur after euthanasia, these procedures do NOT generally need to be entered into a protocol. However, the eProtocol system requires at least one procedure be entered for each protocol, so this option is made available for groups whose only manipulation of animals is tissue harvest after humane euthanasia.

We will appreciate all you can do to avoid waiting until the last day.

Any new protocol submitted after 4:00 p.m. on Friday, November 19 will not be reviewed until the January 10, 2011 Full Committee Review.

The next IACUC Full Committee Review (FCR) is **December 13, 2010**.

The deadline to submit materials for review is **November 19, 2010**.
