Reporting Animal Care Concerns: "Whistle-Blower Policy"

Any person who has concerns regarding any aspect of the care and use of animals in research or teaching at The University of Texas at Austin is encouraged to voice that concern.

There are a number of options available to communicate concerns about animal care and use at The University of Texas at Austin, or to report instances of suspected noncompliance with laws, rules, regulations, and policies. The names and phone numbers of contact persons, including the Attending Veterinarian, the Director of the Office of Research Support (ORS), and the Compliance Hotline should be posted in animal facilities. The Attending Veterinarian has the authority and responsibility for ensuring compliance with all animal care and use standards and is an appropriate person to receive initial concerns in most cases. Attached to this newsletter is a poster that contains this information, and should be posted in animal facilities (including labs).
