## IACUC Training Reminders

Based on feedback from many researchers, the ITS support for the IACUC has created automatic training reminders to integrate with eProtocol IACUC. As you know, the IACUC requires personnel working with animals to complete several training items at least once every three years.

The reminder system will provide training expiration reminders at 30 days and 15 days prior to expiration, as well as the day the training has expired. Each protocol PI and Co-PI will be copied on the messages for their laboratory personnel. To help you identify these messages, the subject line will contain the protocol number, information regarding training requirement status (needed, expiring, or expired), the name of the person needing training, and the training course number.

In order to assist you and ensure the ORS is able to facilitate the review of IACUC protocol submissions, protocol revisions and renewals received before December 7, 2011 will be processed before the end of business on Monday, December 19, 2011. Please note that if the documents require substantial revision, we may not be able to complete the review of those changes before the University closes. We will appreciate all you can do to avoid waiting until the last day.

Any new protocol submitted after 4:00 p.m. on Friday, November 18, 2011 will not be reviewed until the January 9, 2012 Full Committee Review.

The next IACUC Full Committee Review (FCR) is **December 12, 2011**.

The deadline to submit materials for review is **November 18, 2011**.
