eProtocol Tip of the Month

When I try to submit my protocol, nothing happens. HELP!

Use the **Check for Completeness** feature (available on the left-hand menu option) when you believe you have finished entering all of the necessary information.

The "Check for Completeness" will scan your protocol and provide a report indicating which sections may be missing information.

PLEASE NOTE: The check for completeness feature cannot check to see if all of the necessary supporting documents have been attached. Be sure to double-check that this has been done before you submit your protocol.

If the Check for Completeness page indicates that everything is okay, click on the "Submit Form" button within the protocol OR the "Submit to IACUC" button on the comments page (only if you have received comments from the IACUC).

The next IACUC Full Committee Review (FCR) is **April 8, 2013**.

The deadline to submit materials for review is **March 15, 2013.**
