New VAS Requirements

After September 1, 2013, the Vertebrate Animal Section (VAS) of grants and contracts must be consistent with the AVMA Guidelines for the Euthanasia of Animals: 2013 Edition. In their submission to NIH, grant applicants are required to describe any method of euthanasia to be used and the reasons for its selection and to state whether the method proposed is consistent with the 2013 AVMA Guidelines. If the proposed method is not consistent with the AVMA Guidelines, a scientific justification must be included in the VAS. For more information, please see NOT-OD-13-098 {NIH website}.

Flowmeter for Carbon Dioxide Euthanasia Needed Soon

The past two newsletters described the recent revisions to several of the IACUC's guidelines that pertain to euthanasia of laboratory animals. In particular, the recent revisions now require that CO₂ gas must be delivered using a compressed gas cylinder, pressure regulator, and flowmeter.

Flow meters should be in place prior to the next round of IACUC semi-annual facility evaluations, which occur in late September/early October 2013.

VWR International has a campus-wide purchasing agreement that combines competitive pricing with ease of purchasing for UT departments. Their catalog number 89012-426 is an all-in-one CO₂ regulator and flowmeter, which fits the large H-tanks commonly used as a CO₂ source. For retrofit purposes, their catalog number 89012-414 is a 0-12 L/min CO₂ flowmeter that could be attached (with proper fittings and tubing) to compatible existing regulators that can provide 50psi gas flow.

The IACUC has prepared a poster that contains this information and should be posted in animal facilities (including labs). The poster, in both English and Spanish is available on the IACUC website.

The semi-annual evaluations of all the University's animal facilities will occur from **September 30 through October 14, 2013.** This process involves an examination of all areas where animals are used or housed for teaching, research, and/or testing.

You can begin preparing your laboratory for the visit by reviewing the revised "Laboratory Self-Evaluation Checklists" that are available on the "Documents, Materials, and Forms" page of the IACUC website.

The next IACUC Full Committee Review (FCR) is **September 16, 2013**.

The submission deadline for review at this FCR is **August 23, 2013.**
