UT Football Games, Animal Care, and Campus Parking

It is our responsibility to ensure the animals under our care are our first priority. While it may seem like "Mission: Impossible" to find parking around campus during home football games, with a little preplanning and coordination, arrangements can be made with Parking and Transportation Services (PTS) for special event parking.



Parking and Transportation Services

If you need to access areas of campus during home football games, you will need to make prior arrangements with PTS. You will need to complete the Event Parking Request Form at least *two weeks* in advance. Once the form has been submitted, a PTS representative will contact you. Please note: you must have a current parking permit before you can request special event parking.

Reporting Animal Care Concerns: "Whistle-Blower Policy"

Any person who has concerns regarding any aspect of the care and use of animals in research, teaching, or testing at The University of Texas at Austin is encouraged to voice that concern.

Concerns about animal care and use should be reported to the Attending Veterinarian, the Institutional Animal Care and Use Committee, or University Compliance Services. The names and phone numbers of these contact points should be posted in animal facilities and laboratories.

The IACUC has prepared a poster that contains this information and should be posted in animal facilities (including labs). The poster, in both English and Spanish, is available on the IACUC website.

Semi-Annual Facility Evaluations: Coming Soon!

The semi-annual evaluations of all the University's animal facilities will occur from **September 30 through October 14, 2013.** This process involves an examination of all areas where animals are used or housed for teaching, research, and/or testing.
